HATBORO, PA (November 14, 2001) – Penn-America Group, Inc. (NYSE:PNG) today declared a quarterly cash dividend of \$0.0525 per common share. The quarterly dividend is payable December 12, 2001, to shareholders of record at close of business as of November 28, 2001. The decision was made at a meeting of the company’s board of directors today.
